## Note:

Also note that compensation is based on the ministry task performed and not on the type of authorization. Many of the compensation guidelines set by conferences are designed to address compensation needs for local church pastors and do not cover employment benefits for other church staff members, so read them carefully. However, they may be used to help negotiate compensation for an authorized minister in a Christian education position.
